1. Introduction: what a publication scheme is and why it has been developed?

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme will shortly be available for you on our new website to download and print off and is available in paper form in a file in the foyer.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Our Aims and Objectives

We promote high achievement in all aspects of education by working together so that the children:

- *aim for personal excellence in Literacy, Numeracy and all other subjects*
- *receive a broad, balanced and creative curriculum*
- *are honest, fair, tolerant and truthful*
- *respect and are sensitive to the beliefs, faiths and cultures of others, whilst developing an understanding of Christian beliefs, practices and values*
- *are aware of the necessity of a healthy lifestyle and the importance of exercise*
- *enjoy school as a happy and positive experience*
- *develop independence*
- *benefit from learning links between home and school*
- *develop high self-esteem*

We believe that each child will succeed through experiencing:

- *a broad, balanced and challenging curriculum which promotes creativity and makes school a happy and positive experience*
- *high quality teaching and learning opportunities*
- *a window on the world outside the child's experience*
- *effective partnerships between school, home and the community*
- *high quality leadership, management and team work by all staff and governors to continue to develop the school for the benefit of all pupils*
- *well managed financial resources ensuring quality education for all*
- *an environment that is open and secure to encourage honesty, tolerance, independence, celebration and responsibility*

and this publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as ‘classes’. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

<i>School Prospectus</i>	information published in the school prospectus.
<i>Governors’ Documents</i>	information published in the Governors Annual Report and in other governing body documents.
<i>Pupils & Curriculum</i>	information about policies that relate to pupils and the school curriculum.
<i>School Policies and other information related to the school</i>	information about policies that relate to the school in general.

Accessibility Plans	Plan for increasing participation of disabled pupils in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled pupils.

Child Protection Policy	Statement of policy for safeguarding and promoting welfare of pupils at the school. <i>(from March 2004)</i>
